## Retiring Mayor Takes a Look Back

## Stresses "City of Kindness"

Culver City Mayor Jeff Cooper was beaming as he addressed over 400 residents and business people on Tuesday at the annual Mayor's luncheon.

"Culver City is at the cutting edge of cities around the country, in terms of what we have been able to accomplish, and what we plan to accomplish going forward," he stated during the luncheon where he discussed his tenure on the City Council.

The packed house listened as the introspective mayor listed the accomplishments during his eight years in office

and his dodination to "our oit

munity," he said. "Its 21 miles of underground fiber is designed for geographic diversity, security and redundancy.'

Cooper spoke about the progress the council has

Finance was another topic the mayor was happy to talk about.

"Through it all, our City Finances remain much stronger than those of our peer cities," he said. "This year we completed refinancing of all old Redevelopment Agency bonds, providing ongoing savings through 2028 that will benefit both the City and Culver City Unified School District."

The mayor also spoke of challenges the city continues to face, including homelessness, and the availability of affordable housing.

He also talked about the current political climate.

## Publisher, Councilmember Threatened with Criminal Prosecution

The Culver City Observer and Councilman Jim Clarke have received notice from Culver City Resident Les Greenberg that he had sent a letter to Scott Bixby, Culver City Chief of Police requesting criminal charges be filed against Culver City Observer Publisher Steve Hadland and Culver City councilman Jim Clarke.

Observer Publisher Hadland stated, "I stand firm on the right of the press to provide necessary information to the public. While I believe the First amendment to the constitution applies here and I quote, 'Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press....' I would risk going to jail before I would fail in my responsibilities to keep the residents of Culver City informed."

The letter arrived at the Observer offices just before press time. We will be reaching out to Councilman Clarke and Chief Bixby for their comments.



#### CORRECTION

Jay Wierenga, Communications Director of the Fair Political Practices Commission issued the following clarification to the statement which appeared in the March 15, 2018 edition of the Culver City Observer:

"First of all, we don't administer 'California State Election codes'. The Secretary of State monitors elections, and election code is not in our section of law. We only have jurisdiction over the Political Reform Act, so I would never and did not say anything about California State Election codes. I also do not recall and would likely not say we've been advised of a possible violation... I only say what I/we can say, that if we receive a complaint, we can confirm receipt of a complaint. No mention was made asking me/us if we received a complaint, so therefore I wouldn't have said that 'we'd been advised of a violation'. We did look up to see if there was a committee on file with the Secretary of State, and there did not appear to be."

Culver City Teacher's Pensions from Transparent California was the headline in Neil Rubenstein's column on March 15. Within this lengthy column (tackling many subjects) was a list of retired teachers' names and pension amounts, including ours, followed by this sentence.

"In 2016, Teacher pensions paid a total of \$11,390,424. In the opinion of many we need a Beverly Hills CPA and a Philadelphia lawyer to keep expenses under control, but now you know the real reason the school district needs more money its pensions and wages."

You might think that Mr. Rubenstein is simply misinformed, that he does not know that our pensions come from the State Teacher Retirement System (STRS), not the Culver City Unified School District budget. But wait – on February 22, in response to an earlier list of names and amounts in his column, you published a Letter to the Editor from our colleague and retired principal Dr. Marvin Brown, which clearly and cogently explained how STRS works, and that the money comes from a statewide fund into which educators, our employing districts and the state paid over the years of our employment.

If Mr. Rubenstein continues writing about how our pensions contribute to CCUSD's financial burden, what does that say about other opinions he expresses?

crosses political lines, and is just outright mean and nasty," said the mayor. "All of us from both sides of the political arena need to stand up loud and clear and say enough of this bull shit, Culver City is better than this!"

Cooper also paid tribute to community leaders who died in the past year, including Scott Wyatt, Madeline Ehrlich, Margaret Lindgren, Vince Motyl, MaryAnn Fernandez, andMim Shapiro.

"All were dedicated community members from different ends of the political spectrum, but the one big thing they had in common was their love for Culver City," he said.

He also paid tribute to the late Steve Rose, "the face of this Chamber and Culver City for many decades, and whose shoes will never be filled."

He stated that The "Citizen of the Year" – which was started last year by then Mayor Jim Clarke – will be renamed: the "Steve Rose Citizen of the Year".

The 2018 winner of the "Steve Rose Citizen of the Year" award will go to that "little flower, AKA, Earl Eskridge," he added.

The mayor also thanked his wife Rafia, his daughters and all who worked with him this year.

cussions, the developer has notified the City of its intention to forego presenting a community benefits proposal to the City Council on March 26th. The result of this decision means that the project will not be presented to the City Planning Commission in April as originally intended. It also means that any decision regarding a community benefits proposal or the project itself will be left up to the new Council to decide.

In a joint statement, Council members Eriksson and Clarke felt that more time was needed by all parties the Fox Hills community, the City staff and the developer - to ascertain what type of project best fits the needs of the surrounding residents and the City as a whole. 'It is our hope that all sides will utilize the time wisely to redesign a project that can be seen as an example of smart and practical development that adds value to Culver City's brand. We also recognize that postponing the project for now will not maintain the status quo as the Marshall's store has already given notice that it will close in a year.

It is incumbent upon everyone to ensure this valuable piece of property at the gateway to Culver City does not become decrepit and underutilized'."

The development has been under attack by Fox Hills residents for over two years. During the 2016 City Council race flyers were distributed erroneously stating the plaza would be converted to a used car dealership.

The project known as 'The Bristol Parkway Comprehensive Plan' on the 6.25 acre commercial site would begin with the demolition of 60,157 sf retail buildings followed by development of 662 apartment units, 50 live work units, approximately 21,000 sf of retail space, 1,148 space subterranean parking structure; and over 3 acres of landscaped open space for public and private use.

Residents were concerned about the size of the project and the traffic congestion it would bring to a part of the city already suffering from traffic.
